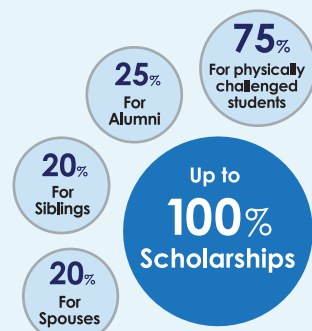

## Master of Laws (LLM)

### Course Curriculum

A student would be awarded LLM degree after completion of 1 (one) academic year earning 40 credits in 2 (two) semesters with at least CGPA of 2.50. In each semester not more than four courses shall be offered and each course will carry 100 marks. The viva-voce is compulsory for all at the end of the second semester.
